STEPS IN QATAR VISA PROCESSING

STEP 1: ASSESSMENT	Read and sign our <u>Data Privacy Agreement & Visa Waiver</u> , then email it together with the accomplished <u>Questionnaire</u> for Free Assessment. This will allow us to evaluate your chances of approval. Kindly send these to our Visa Department by sending a message through: >> Facebook: @HMGCWebjetMolino/@HMGCLasPiñas
STEP 2: PAYMENT	After the assessment, and should you wish to proceed with the application, our Visa team will then provide your invoice. Proceed to settle, then send your proof of payment.
STEP 3: ENDORSEMENT & PROCESSING	The Visa Team will endorse you to the next available Visa Consultant, who will verify your payment before processing your application.

IMPORTANT NOTES

- ❖ Applicants are advised to plan accordingly and allow sufficient time for the visa process. It is encouraged to apply three (3) months prior to your intended travel date.
- ❖ Each visa application is subject to individual assessment, and processing times may vary before a schedule can be confirmed.
- ♦ We cannot guarantee 100% approval as it depends upon the discretion of the Consul/Visa Officers, but we will make sure that you are 90% sure before your scheduled appearance.
- Consul will advise the applicant whether their application is granted or not on the day of your appointment.
- ❖ If granted, you will receive your passport with the attached visa copy 5-7 working days after the appearance. PHP 440/passport is collected by LBC upon delivery.
- ❖ We do not require any confirmed Airline Ticket and Hotel Accommodation for every visa application; thus, in any case of delayed results and/or refusal of application, HMGC Travel & Tours shall not be held liable for the costs of airline ticket/s and hotel accommodation/s.
